ELIGIBILITY CRITERIA

MCM SCHOLARSHIP-2011-12(Renwal)

a. MERIT CRITERION:

- i. The students' academic performance in the two consecutive semesters of the preceding Session (2010 -11) i.e. the GPA (Credit based weighted average) of preceding two semesters as updated after the Supplementary Examination which followed the Session, **must not be lower than 7.00** without any back log subject(s) and clearing all prescribed credit requirements.
- ii. Students having backlog in any subject and not able to clear during the same session, i.e. in 2010-11, are not eligible to apply for MCM Scholarship and Free-studentship for the session of 2011-12.
- iii. Those students against whom the **Disciplinary Action** have been taken or pending against them during the preceding year (2010-11) or they have been punished by the competent authority under examination malpractice and involved in violation of code of conduct in Instituted/Hall of Residence(Hostel)/Department /Gymkhana, are **NOT ELEGIBLE FOR AWARD OF MCM SCHOLARSHIP & FREESTUDENTSHIP 2011-12.**

b. MEANS CRITERION:

- i. The Annual Income of a student's parents/ guardian and his family from all sources in the preceding financial year of 2010 -11(from 1st April 2010 to 31st March, 2011) **must not exceed Rs.4,50,000/- (Rupees Four Lakhs Fifty thousand).**

N.B :Number of MCM Scholarship awardees shall be restricted to 25% of the total students strength, admitted in each year.

FREE STUDENTSHIP:

ELIGIBILITY : Those students who satisfy the specified "Means Criterion" as stated above , but do not satisfy "Merit Criterion" , may be granted exemption from payment of Tuition Fee, subject to approval on merit of each case by the competent authority and subject to clearing all prescribed credit requirement during the session 2010-11 without any backlog subject.

N.B :Number of Free- studentship awardees shall be restricted to 10% of the total students strength, admitted in each year.

Students are advised to obtain the MCM Scholarship Application Forms (to be downloaded from Institute **Web page**) as applicable according to their guardians' occupation along with all Annexures , Guardians' Income Certificate etc. , and submit the forms duly completed with all relevant documents as stated in the **Annexure-II " List of Documents to be submitted"** to the Academic Section in a closed envelop on or **before 25.08. 2011.**

NO APPLICATION WILL BE ENTERTAINED BEYOND 25thAugust, 2011.
