Recent Developments and activities

Maiden Visit of Hon'ble Union Railway Minister Shri Ashwini Valshnaw and Announcement of C2S Programme at IIT Bhubaneswar



The Hon'ble Union Minister for Railways, Communications, Electronics & IT, Shri Ashwani Vaishnaw Ji undertock his first ever visit to IIT Bhubaneswar on 2407.2022. Hon'ble Minister made a huge announcement towards approval of the Hon'ble Prime Minister sanctoning of the project and establishment of the centre named Chips to Startup (C25) at IIT Bhubaneswar. IIT Bhubaneswar became the Jast Institute of the country to get this honour of Chip Designing and Manufacturing.



- The present strength of non-teaching employees is 88 Nos against the sanctioned strength of 129 Nos. Subsequently, with the concurrence of the MoE, the Board of Governors approved the Recruitment and Promotion Policy with an additional 135 nos of employee in its 44th meeting held on 11.03.2022. Accordingly the present sanction strength is 264.

	Board approved the recommendations of 46 th meeting of the Finance Committee held on 14.09.2022.
BoG:47-5	To consider the proposed amendment to the tripartite agreement with IIT Bhubaneswar, PHEO, Govt. of Odisha and MEIL towards supply of Bulk Water to the Institute.
	The Board discussed the proposal of Govt. of Odisha towards reduction of 2 MLD water from the agreed quantum of 5 MLD. But, it was decided that since the dispute is sub-judiced under the Arbitration Tribunal, any kind of decision towards amendment of agreement at this stage would not be appropriate. Rather, the Institute may substantiate their claim before the Arbitration Tribunal by giving a detailed breakup of the impact of both fixed cost and variable cost incurred in the execution of the project.
	The Board also agreed to the recommendation of the FC on deferring of proposal of Govt. of Odisha in amending quantum of water till receipt of the outcome of the Arbitration Tribunal.
BoG:47-6	To consider and approve the Annual Report for the Financial Year 2021-2022 of the Institute.
	The Board of Governors considered the Annual Report submitted by the Institute for the financial year 2021-2022 and approved the same. Annual Report will be sent to MoE for laying before both the Houses of Parliament.

BoG:47-7 To consider and approve the additional requirement of the Teaching & Non-teaching posts in the Institute.

The Board discussed the matter in detail and agreed to the recommendation of the FC that the Institute may recruit both the teaching and non-teaching staff keeping in view of the ratio of 10:1:1.1 approved by the Ministry of Education (then Ministry of HRD) vide their letter No. F. No. 32-14/2013-TS.1 dated 10.06.2013 and No.F.22-19/2006-TS-I dated 01.08.2008. The Financial Advisor, MoE and member of FC present in the meeting had observed that this may require specific approval of the Ministry. However, as per the comments received from AS (TE) giving concurrence to increase the sanctioned strength, as per the approved ratio without creating the new post, Board approved the proposal upon recommendation of the FC.

BoG:47-8 To consider and approve Continuity of MCM/ Fee remission for academic year 2022-23 out of IRG or for discontinuance of the scheme due to non-release of grant by MoE for the purpose.

The matter was deliberated in detail. FC recommended to the Board that MCM scholarship to the eligible students may be disbursed by the Institute from Institute Internal Resource Generation (IRG) and the same may be claimed to the Ministry along with the demand for the grant including both Budget Estimate and Revised Estimate for reimbursement. The claim of such fund from the Ministry be persuaded regularly and reported to the Board about its outcome.

Board may take a view in its next meeting in case the claim under scholarship is not reimbursed by the Ministry.

- a. Extra financial implication of 6% GST will be applicable from 01.01.2022
- b. The offer of the L1 bidder is lower than the present market rates
- c. L1 bidder is unwilling to further reduce the rates during negotiations

It is to report to the BoG that The Institute concurred to the proposal of NBCC due to the following reasons :

- d. The subject work will attract GST @18% i.e. an increase of 6% due to change in notification w.e.f. 01.01.2022 whereas the estimates were prepared in 2021 with 12% GST.
- e. In case of recall of tender, there are likely chances of an increase in rates due to the upward trend of market rates
- f. The Institute can't rely on the underground borewells for long for its water supply due to the gradual depletion in water level and have to ultimately shift to river water source. In order to distribute the river water from our current reservoirs, the proposed project is essential and hence recommended.
