**a. Merit cum Means (MCM) Scholarship - Fresh**


The rate of MCM scholarship shall be Rs.1000/-P.M. for twelve months along with the full tuition fee reimbursement for two semesters.

Payment of MCM Scholarship shall be subject to further condition that:-

- a. **No Scholar will be permitted to enjoy more than one Scholarship/ Financial Assistance/ Stipend etc. either awarded by this Institute or by any outside organisation/central/state Government etc. during the same period.**
- b. In the event of an awardees becoming eligible for another Scholarship/ Financial Assistance /Stipend etc. from any other source, he/she will have option to retain any one award as per his/her choice under intimation to the undersigned. No students shall be permitted to avail of more than one Scholarship/financial assistant under any circumstance. The students have to sign a prescribed undertaking form for 2017-18 academic sessions before receiving the said scholarship.

Payment of Scholarship & Free studentship would be retrospectively effective from **July 2017**. A scholar has to refund the amount of Scholarship/Financial benefits etc. if he/she leaves the Institute on his/her own accord before the completion of the session during the tenure of the Scholarship/Financial benefit.
