The family Annual Income Certificate for the year **2015-16** as per parents' occupational status (i.e. If Service then Salary Certificate, **Annex- 2 Form-X** with other relevant enclosures / if Business , Agriculture etc. then Affidavit , **Annex- 3, Form-Y** with other relevant enclosures / if Pensioner , then Pension Certificate **Annex-4 , Form-Z** with other relevant enclosures as applicable, as stated in **Annexure- 1** (List of Documents to be Submitted) as per parents/guardians' occupational status.

All the above Annexures / Forms related to parental income certificates etc. can be downloaded from ERP Site / Institute Website. The Application Form duly enclosing all the relevant documents / annexures as stated above should be submitted to Academic Section on or before 18th October, 2016. The Hard Copy of Application form must be signed both by student and his/her guardian otherwise it will be treated as cancelled.
