1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Generic

Bidders shall quote only those products (Part of Service delivery) in the bid which are not obsolete in the market and has at least 1 years residual market life i.e. the offered product shall not be declared end-oflife by the OEM before this period.

3. Scope of Supply

Scope of supply (Bid price to include all cost components) : Supply Installation Testing and Commissioning of Goods

4. **OEM**

IMPORTED PRODUCTS: In case of imported products, OEM or Authorized Seller of OEM should have a registered office in India to provide after sales service support in India. The certificate to this effect should be submitted.

5. Service & Support

Availability of Service Centres: Bidder/OEM must have a Functional Service Centre in the State of each Consignee's Location in case of carry-in warranty. (Not applicable in case of goods having on-site warranty). If service center is not already there at the time of bidding, successful bidder / OEM shall have to establish one within 30 days of award of contract. Payment shall be released only after submission of documentary evidence of having Functional Service Centre.

6. Service & Support

Dedicated /toll Free Telephone No. for Service Support : BIDDER/OEM must have Dedicated/toll Free Telephone No. for Service Support.

7. Service & Support

Escalation Matrix For Service Support : Bidder/OEM must provide Escalation Matrix of Telephone Numbers for Service Support.

vi) Payment Term : 100% payment will be made after delivery, installation & satisfactory acce ptance by the user subject to submission of all requisite documents i.e Delivery Challan, Origi nal Tax invoice with mentioning the Institute GST Number 21AAAAI2760A1ZJ, GeM Contract N o & date in the Invoice, Warranty Certificate in Original duly stamped and signed with clearly mentioning the Warranty Period started from the date of installation/user acceptance to end o f the warranty date, Installation Certificate in Original etc.

vii) DELIVERY WITH INSURANCE: The date of delivery should be strictly adhered to failing whic h the purchase order is liable to be cancelled. Penalty may be imposed as per P.O. terms & co nditions. Goods should be securely, safely and adequately packed, insured & dispatched at th e risk of supplier and packing costs quoting this order reference should be kept in all package . Local firms are requested to deliver the goods in our stores before 3.00 PM on any working d ay.

viii) All damaged or unapproved goods shall be returned at your cost & risk and the incidental expenses incurred thereon shall be recoverable from any of your bill.

ix) WARRANTY: Ordered materials should have 03(Three) Years onsite OEM Warranty from the date of installation/commission & acceptance by the user. In case at the time of installation of stores / part of stores are found defective / damaged during or after delivery to consignee, th e supplier will replace the stores. If the stores / part of stores are found defective / damaged during the warranty period, the supplier will repair/replace the stores at consignee's location i n India free of cost or if any case it is required to send back to Foreign/Local manufacturer, su pplier should bear the cost. Bank Guarantee equivalent to the cost of equipment is required t o be submitted before lifting the store. All expenses including freight, insurance, custom duty for export/import and all clearance charges etc. in this regard will be borne by the supplier. T he equipment under warranty period must be attended & problems rectified immediately with in 48 hours of lodging of complaint by the Institute and this may be considered as the down ti me. The warranty period shall automatically be extended for such period for which the equip ment is not attended & rectified on lapses of the down time.

x) Delivery period : Delivery, installation, commissioning & demonstration should be complete d within 21 days from the date of the issue of the GeM Contract.

xi) LIQUIDATED DAMAGES: As time is the essence of this order, the date of delivery, Installati on, Commissioning and demonstration should be strictly adhered to, otherwise the delivery, I nstallation, and Commissioning in full or in part may not be accepted and penalty for late deli very/Installation/ Commissioning will be imposed @ 0.5% of the contract value per week or par t of the week of the delayed period, subject to a maximum of 10% of the total value of supply order & beyond 10% subject to approval of the Competent Authority of the Institute. In case o f cancellation of order no compensation will be paid towards progress of order/procurement.

xii) CANCELLATION: Printed conditions, if any, contained in or sent along with the quotation sh all not be binding on us. IIT Bhubaneswar reserves all the rights cancel the Purchase Order at any stage without assigning any reason thereof.

xiii) JURISDICTION: For any dispute, the place of jurisdiction shall be Bhubaneswar, India only.

xiv) IIT Bhubaneswar reserves the right to accept or reject or cancel any or all enquiries or qu otations/Bid at any stage without assigning any reason thereof.

xv) False declarations will be in breach of the Code of Integrity under Rule 175(1)(i)(h) of the General Financial Rules for which a bidder or its successors can be debarred for up to two yea rs as per Rule 151 (iii) of the General Finance Rules along with such other actions as may be permissible under law.

xvi) Offer Price: The bidder must be quoted the price (final offer) on F.O.R. destination IIT Bh ubaneswar basis. Offered price must be included all charges i.e. Packing & Forwarding, Freigh t, custom clearance, cargo handling, GST and Insurance etc. whichever is applicable as per G ol norms.
