1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.

2. If the bidder is a Startup, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to their meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.
3. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.

4. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. Only Class-I and Class-II Local suppliers as per MII order dated 4.6.2020 will be eligible to bid. Non - Local suppliers as per MII order dated 04.06.2020 are not eligible to participate. However, eligible micro and small enterprises will be allowed to participate .The buyers are advised to refer the OM No.F.1/4/2021-PPD dated 18.05.2023.

5. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have guoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 OM\_No.1\_4\_2021\_PPD\_dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

6. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 50% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. In case of bunch bids, the category related to primary product having highest bid value should meet this criterion.

7. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:

- i. If number of technically qualified bidders are only 2 or 3.
- ii. If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.
- iii. In case Primary product of only one OEM is left in contention for participation in RA on elimination of H-1.
- iv. If L-1 is non-MSE and H-1 is eligible MSE and H-1 price is coming within price band of 15% of Non-MSE L-1
- v. If L-1 is non-MII and H-1 is eligible MII and H-1 price is coming within price band of 20% of Non-MII L-1

### 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

### 2. Generic

Bidders shall quote only those products (Part of Service delivery) in the bid which are not obsolete in the market and has at least 1 years residual market life i.e. the offered product shall not be declared end-oflife by the OEM before this period.

#### 3. Scope of Supply

Scope of supply (Bid price to include all cost components) : Supply Installation Testing and Commissioning of Goods

# 4. **OEM**

IMPORTED PRODUCTS: In case of imported products, OEM or Authorized Seller of OEM should have a registered office in India to provide after sales service support in India. The certificate to this effect should be submitted.

### 5. Service & Support

Availability of Service Centres: Bidder/OEM must have a Functional Service Centre in the State of each Consignee's Location in case of carry-in warranty. (Not applicable in case of goods having on-site warranty). If service center is not already there at the time of bidding, successful bidder / OEM shall have to establish one within 30 days of award of contract. Payment shall be released only after submission of documentary evidence of having Functional Service Centre.

#### 6. Service & Support

Dedicated /toll Free Telephone No. for Service Support : BIDDER/OEM must have Dedicated/toll Free Telephone No. for Service Support.

#### 7. Service & Support

Escalation Matrix For Service Support : Bidder/OEM must provide Escalation Matrix of Telephone Numbers for Service Support.

#### 8. Buyer Added Bid Specific ATC

i) Bidders must submit the Similar GeM Contract copies executed in Institutions of National Im portance like, IITs, NITs, IISERs, NISER, Central Universities etc. Failure to submit the same, Bi d may be rejected.

ii) Bidders must submit the Manufacture Authorization Form, Declaration for Local Content dul y signed by OEM as per Annexures attached. Failure to submit the same, Bid may be rejected.

iii) Bidder must submit the Bidder Details, Acceptance for Bid Terms and Conditions, Bid Securing declaration certificate and Vendor Master Form as per Annexures attached. Failure to submit the same, Bid may be rejected.

vi) Bidder must submit the Firm registration/ incorporation certificate, GST registration certificate and PAN of the firm along with bid documents. Failure to submit the same, Bid may be re jected.

vii) Payment Term : 100% payment will be made after delivery, installation & satisfactory acce ptance by the user subject to submission of all requisite documents i.e PBG 5% of contract val ue, Delivery Challan, Original Tax invoice with mentioning the Institute GST Number 21AAAAI 2760A1ZJ, HSN/SAC code, Bank account details, Exact item description and Contract value as per GeM Contract, GeM Contract No & date in the Invoice, Warranty Certificate in Original wi th clearly mentioning the Warranty Period started from the date of installation/user acceptanc e to end of the warranty date, Installation Certificate in Original etc and all documents must b e stamped and signed by the authorized person of the firm.

viii) DELIVERY WITH INSURANCE: The date of delivery should be strictly adhered to failing whi ch the GeM Contract is liable to be cancelled. Penalty may be imposed as per P.O. terms & con ditions. Goods should be securely, safely and adequately packed, insured & dispatched at the risk of supplier and packing costs quoting this order reference should be kept in all package. Local firms are requested to deliver the goods in our stores before 3.00 PM on any working da y.

ix) All damaged or unapproved goods shall be returned at your cost & risk and the incidental e xpenses incurred thereon shall be recoverable from any of your bill.

x) PBG : The successful Bidder has to submit Performance Security of 5% of the total order val ue on or after commission of equipment. Performance Security must valid for 14 (Fourteen) m onths i.e. 2 months beyond the warranty period to cover the warranty. Performance security i s to be issued and sent directly from an Indian Scheduled/Nationalized bank. PBG period start s from the date of the successful installation of the equipment. In case of non-submission of P BG, the equivalent amount will be kept on hold from the Bill amount till completion of Warranty Period + 2 Months. PBG period will start from the date of the installation. xi) WARRANTY: Ordered materials should have 01 (One) Year onsite OEM Warranty from the d ate of installation/commission & acceptance by the user. In case at the time of installation of s tores / part of stores are found defective / damaged during or after delivery to consignee, the supplier will replace the stores. If the stores / part of stores are found defective / damaged du ring the warranty period, the supplier will repair/replace the stores at consignee's location in I ndia free of cost or if any case it is required to send back to Foreign/Local manufacturer, supp lier should bear the cost. Bank Guarantee equivalent to the cost of equipment is required to b e submitted before lifting the store. All expenses including freight, insurance, custom duty for export/import and all clearance charges etc. in this regard will be borne by the supplier. The e quipment under warranty period must be attended & problems rectified immediately within 4 8 hours of lodging of complaint by the Institute and this may be considered as the down time. The warranty period shall automatically be extended for such period for which the equipment is not attended & rectified on lapses of the down time.

xii) Delivery period : Delivery, installation, commissioning & demonstration should be complet ed within 60 days from the date of the issue of the GeM Contract.

xiii) LIQUIDATED DAMAGES: As time is the essence of this order, the date of delivery, Installati on, Commissioning and demonstration should be strictly adhered to, otherwise the delivery, I nstallation, and Commissioning in full or in part may not be accepted and penalty for late deli very/Installation/ Commissioning will be imposed @ 0.5% of the contract value per week or par t of the week of the delayed period, subject to a maximum of 10% of the total value of supply order. In case of cancellation of order no compensation will be paid towards progress of order /procurement.

xiv) CANCELLATION: Printed conditions, if any, contained in or sent along with the quotation s hall not be binding on us. IIT Bhubaneswar reserves all the rights cancel the GeM Contract at a ny stage without assigning any reason thereof. IIT Bhubaneswar reserves the right to accept o r reject or cancel any or all enquiries or quotations/Bid at any stage without assigning any rea son thereof.

xv) JURISDICTION: For any dispute, the place of jurisdiction shall be Bhubaneswar, India only.

xvi) False declarations will be in breach of the Code of Integrity under Rule 175(1)(i)(h) of the General Financial Rules for which a bidder or its successors can be debarred for up to two yea rs as per Rule 151 (iii) of the General Finance Rules along with such other actions as may be permissible under law.

xvii) Offer Price : The bidder must be quoted the price (final offer) on F.O.R. destination IIT B hubaneswar basis. Offered price must be included all charges i.e. Packing & Forwarding, Freig ht, custom clearance, cargo handling, GST and Insurance etc. whichever is applicable as per Gol norms.

xviii) As per CVC guidelines OEM and their authorised dealer/partner cannot bid simultaneou sly for the same item in same tender. In such case, OEM Bid will be considered.

xix) After opening of the technical Bid, the bidder may be asked in writing or online(through e mail/gem portal) to

clarify on the uploaded documents provided in the technical bid, if necessary, with respect to any doubts or the

illegible documents required for technical evaluation. Institute may ask for any other docume nts/information during technical evaluation of the tender. Provided in all such cases, furnishing of any such documents in no way alters the bidders price Bid. Institute may reserve the right t o accept any additional document.

xx) For examination, evaluation and comparison of bids, Institute may at his/her discretion to ask the lowest bidder for clarification of his rates including reduction of rate on negotiation an d breakdown of unit rates as per Gol rules.
