


1. Mode of Fee Payment for all on roll Students:

(a) **Institute Fee:** Online payment in ERP following the step as under:

- 1 Login into EIMS (Link: <https://eims.iitbbs.ac.in>)
- 2 Click on "Academic"
- 3 Click on "Fees"
- 4 Click on "Fee Demand and Payment"
- 5 Complete the payment process.

2. Mode of payment for Students availing Bank Loan:

(i) **Institute Fee:** Students are required to pay their fees through NEFT by following the step mentioned below:

1. Login into EIMS (Link: <https://eims.iitbbs.ac.in>)
 2. Click on "Academic"
 3. Click on "Fees"
 4. Click on "Fee Demand and Payment"
 5. Generate NEFT challan:
 - (a) Click on SBI Branch payment for payment through SBI
- OR
- (b) Click on NEFT for payment through Banks other than SBI
6. Submit the challan to your bank for NEFT/ online transfer
- (No other mode of payment is acceptable)

(ii) **Hostel Mess Advance:** The concerned bank is required to transfer the amount only through NEFT (Online Transfer) to the following account number: Canara Bank A/c No. 80072200011951, IFSC Code: CNRB0017282, Canara Bank, Argul Branch, Account Holder Name: IIT Bhubaneswar Hostel Account.

N.B.: 1) The Bank must include the following details of students in the transaction narration field only, without which, the payment will not be accepted.

- (a) Name of the student,
- (b) Roll No
- (c) Semester for which the loan has been sanctioned

2) Students have to send the loan sanction letter issued by the bank authority to fa.students@iitbbs.ac.in and a copy to office.academic@iitbbs.ac.in & fa.section@iitbbs.ac.in at the time of payment of semester fees.

3) Students seeking fee payment extension due to delay in bank loan have to submit application (hard copy) to the Academic Office and Accounts Office with loan sanction letter from the concerned bank **latest by 25.12.2024**


4) Students are advised to increase their UPI payment limit through their respect bank and ensure that the registration fee is paid in a single transaction for a smooth and hassle-free payment.

5) If any student is paying the registration fee in different lots/ multiple transaction, he/she must follow the same bank gateway (Bank) to pay registration fee and complete the registration.

6) Students are advised to pay the full amount of registration fee in one transaction. In case of part payment, Students are advised to pay the full amount for at least one component.

7) The students availing bank loan are advised to generate challan in the EIMS and submit the same to the bank providing the loan. After the payment is released, the students must update the payment status in EIMS.

8) Fee payment, due clearance and subject registration of all students (including the students availing bank loan), should be completed **by 2nd January, 2025** failing which, without justified reasons will be considered as 'Late Registration' and a late fine shall be imposed for such cases.
