1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.

2. If the bidder is a Startup, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to their meeting of quality and technical specifications. 3. Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.

4. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match

L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 <u>OM_No.1_4_2021_PPD_dated_18.05.2023</u> for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

5. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 80% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. In case of bunch bids, the category related to primary product having highest bid value should meet this criterion.

6. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:

- i. If number of technically qualified bidders are only 2 or 3.
- ii. If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.

1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to

increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Scope of Supply

Scope of supply (Bid price to include all cost components) : Supply Installation Testing and Commissioning of Goods

3. Purchase Preference (Centre)

Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for percentage of 20% of total value.

4. Purchase Preference (Centre)

Purchase Preference linked with Local Content (PP-LC) Policy:

The bid clause regarding "Preference to Make In India products" stands modified in this bid and shall be governed by the PPLC Policy No. FP-20013/2/2017-FP-PNG dated 17.11.2020 issued by MoP&NG as amended up to date. Accordingly, bidders with Local Content less than or equal to 20% will be treated as "Non Local Supplier". The prescribed LC shall be applicable on the date of Bid opening. Sanctions on the bidders for false / wrong declaration or not fulfilling the Local Content requirement shall be as per the PPLC policy. Further following additional provisions are added in the certification and verification of local content provision of the Preference to Make in India clause:

- i. In case of foreign bidder, certificate from the statutory auditor or cost auditor of their own office or subsidiary in India giving the percentage of local content is also acceptable. In case office or subsidiary in India does not exist or Indian office/subsidiary is not required to appoint statutory auditor or cost auditor, certificate from practicing cost accountant or practicing chartered accountant giving the percentage of local content is also acceptable.
- ii. Along with Each Invoice: The local content certificate (issued by statutory auditor on behalf of procuring company) shall be submitted along with each invoice raised. However, the % of local content may vary with each invoice while maintaining the overall % of local content for the total work/purchase of the pro-rata local content requirement. In case, it is not satisfied cumulatively in the invoices raised up to that stage, the supplier shall indicate how the local content requirement would be met in the subsequent stages.
- iii. The bidder shall submit an undertaking from the authorized signatory of bidder having the Power of Attorney along with the bid stating the bidder meets the mandatory minimum LC requirement and such undertaking shall become a part of the contract.

5. Service & Support

Dedicated /toll Free Telephone No. for Service Support : BIDDER/OEM must have Dedicated/toll Free Telephone No. for Service Support.

6. Service & Support

Escalation Matrix For Service Support : Bidder/OEM must provide Escalation Matrix of Telephone Numbers for Service Support.

7. Warranty

Warranty period of the supplied products shall be as given in specifications from the date of final acceptance of goods or after completion of installation, commissioning & testing of goods (if included in

the scope of supply), at consignee location. OEM Warranty certificates must be submitted by Successful Bidder at the time of delivery of Goods. The seller should guarantee the rectification of goods in case of any break down during the guarantee period. Seller should have well established Installation, Commissioning, Training, Troubleshooting and Maintenance Service group in INDIA for attending the after sales service. Details of Service Centres near consignee destinations are to be uploaded along with the bid.

8. Warranty

Timely Servicing / rectification of defects during warranty period: After having been notified of the defects / service requirement during warranty period, Seller has to complete the required Service / Rectification within 5 days time limit. If the Seller fails to complete service / rectification with defined time limit, a penalty of 0.5% of Unit Price of the product shall be charged as penalty for each week of delay from the seller. Seller can deposit the penalty with the Buyer directly else the Buyer shall have a right to recover all such penalty amount from the Performance Security (PBG).Cumulative Penalty cannot exceed more than 10% of the total contract value after which the Buyer shall have the right to get the service / rectification done from alternate sources at the risk and cost of the Seller besides forfeiture of PBG. Seller shall be liable to re-imberse the cost of such service / rectification to the Buyer.

9. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

- 1. Bidders must submit previous POs of similar item supplied important institutions like, IITs, NITs, IISERs , NISER, and Central Universities etc. Failure to submit the same, Bid may be rejected.
- 2. Bidders must submit the Manufacture Authorization Form, Declaration for Local Content duly signed b y OEM as per Annexures attached. Failure to submit the same Bid may be rejected.
- 3. Bidder must submit the Bidder Details, Acceptance for Bid Terms and Conditions, Bid Securing Declara tion certificate and Vendor Master Form as per Annexures attached. Failure to submit the same, Bid ma y be rejected.
- 4. Warranty 06 Months from the date of the installation.
- 5. Bidder must submit the undertaking regarding land Border Sharing as per Office Memorandum dated 23.07.2020 issued by Dept. of Expenditure as per Annexure II attached. Failure to submit the same, Bid maybe rejected.
- 6. Payment Term : Payment will be made after delivery, installation & satisfactory acceptance by the us er subject to submission of all requisite clear documents i.e PBG 5% of total order Value valid till 08 mo nths from the date of installation, Delivery Challan certified with exact date of supply by the consignee, Original Tax invoice, Warranty Certificate, Installation Certificate etc. If the supplier fails to submit the P BG, the Institute will release 95% payment and the balance 5% will be released after completion of the warranty period + 2 months only.
- 7. INSTALLATION: Wherever installation is required the same should be done by the supplier within 30 da ys of the supply of the equipment failing which the purchase order is liable to be cancelled/penalty may be imposed as per Purchase Order terms and conditions. In case the item ordered for is a machine/equi pment the same should be successfully installed and commissioned immediately but in no case later th an one month of the supply of the same. For delay in commissioning beyond the 30-day scheduled perio d, damages as deemed appropriated may be deducted from the Bill/ Agency Commission.
- 8. DELIVERY WITH INSURANCE: The date of delivery should be strictly adhered to failing which the purch ase order is liable to be cancelled. Penalty may be imposed as per P.O. terms & conditions. Goods shoul d be securely, safely and adequately packed, insured & dispatched at the risk of supplier and packing c osts quoting this order reference should be kept in all packages. Local firms are requested to deliver th e goods in our stores before 3.00 PM on any working day.
- 9. All damaged or unapproved goods shall be returned at your cost & risk and the incidental expenses in curred thereon shall be recoverable from any of your bill. Availability of Service Centres: Bidder/OEM m ust have a Functional Service Centre in the State of each Consignee's Location in case of carry-in warra nty. (Not applicable in case of goods having on-site warranty). If the service centre is not already there at the time of bidding, the successful bidder / OEM shall have to establish one within 30 days of award o f the contract. Payment shall be released only after the submission of documentary evidence of having a Functional Service Centre.

- 10. LIQUIDATED DAMAGES: As time is the essence of this order, the date of delivery & installation should b e strictly adhered to, otherwise the delivery in full or in part may not be accepted and a penalty for late delivery will be imposed @ 0.5% of the contract value per week or part of the week of the delayed perio d, subject to a maximum of 10% of the total value of supply order.
- 11. CANCELLATION: CANCELLATION: Printed conditions, if any, contained in or sent along with the quotatio n shall not be binding on us. IIT Bhubaneswar reserves all the right to cancel the Purchase Order at any stage without assigning any reason thereof.
- 12. JURISDICTION: This contract between the supplier and the buyer shall be governed by the LAWS of Indi a and under this contract shall be taken by the parties only in Bhubaneswar, India to competent jurisdic tion.
- 13. As per CVC guidelines OEM and their authorised dealer/partner cannot bid simultaneously for the same item in the same tender. In such case, OEM Bid will be considered.
- 14. After opening the technical Bid, the bidder may be asked in writing or online(through email/gem portal) to clarify the uploaded documents provided in the technical bid, if necessary, with respect to any doubt s or the illegible documents required for technical evaluation. The institute may ask for any other docu ments/information during the technical evaluation of the tender. Provided in all such cases, furnishing of any such documents in no way alters the bidder's price Bid. The institute may reserve the right to acce pt any additional document.

- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.

14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
