Information to Applicants (ITA)

- Dr. Dukhabandhu Sahoo, Associate Professor, School of Humanities, Social Sciences and Management, Indian Institute of Technology, Bhubaneswar (SHSSM) as prospective Principal Investigator intends to select a reputed consultancy firm partner for providing services to undertake large-scale surveys, monitoring of effective implementation and evaluation of various programs / schemes across multiple states.
- 2) **DEFINITIONS**: Unless context or consistency demands, the following terms shall have the meaning assigned to them as given below. However, in case any doubt arises the decision of Institute shall be final and binding on all the parties.
 - 'Owner'/ 'Institute' shall mean Indian Institute of Technology Bhubaneswar and shall include their legal representative, successor and permitted assigns, for example Dr Dukhabandhu Sahoo, Associate Professor, School of Humanities, Social Sciences and Management, Indian Institute of Technology, Bhubaneswar (SHSSM) as prospective Principal Investigator.
 - 'Authorized Representative' shall mean the representative of Consultancy Firm to be selected.
 - "SHSSM" means School of Humanities, Social Sciences and Management
 - "IITB" means Indian Institute of Technology Bhubaneswar.
 - "LLP" means Limited Liability Partnership.
 - "PSU" means Public Sector Undertakings.
 - "PI" means Principal Investigator in SHSSM, IITB
 - "CRT" means Client Representative Team.
 - "PMC" means Project Management Consultancy.
 - "PMU" means Programme/Project Management Unit.
 - "PMS" means Project Management Support.
 - "ISO" means International Organization for Standardization.
 - "Applicant/ Bidder/Tenderer" can be used interchangeably and shall have the same meaning. Similarly, Application / Tender/ Bid also shall have same meaning.

3) ELIGIBILITY CRITERIA:

The Applicants who fulfil the following minimum eligibility requirements shall be eligible to apply. Ineligible applications shall be rejected outright and no further action/technical consideration shall be given to such applicants:

i. **Registered Company/Firm**: The Applicant should be a Company/ Firm/ LLP / PSU registered in India with a track record of providing consulting/ advisory services for at least 5 years as on March 31, 2025. Proof of incorporation shall be submitted.

- ii. **Non- Blacklisting**: The Applicant should not have ever been blacklisted by Government i.e., Central Govt./State Govt./PSU/Governmental Agency/Govt. Department. Applicant must submit an affidavit in this regard.
- iii. Financial Capacity: The Applicant should have an average annual turnover of more than INR 10 (ten) crores from consulting/advisory services in the financial years (2021-22, 2022-23 and 2023-24).
- iv. Similar Experience: The Applicant must have experience in roles such as CRT/PMC/PMU/PMS, or similar advisory/consulting services, and should have undertaken large-scale surveys, monitoring of effective implementation and evaluation of programs / schemes/ project (s) of Central and / or State government projects (ongoing/completed) with a minimum project value of ₹500 Crores (Rupees Five Hundred Crores only) within the last 10 years.
- v. Key Expert required: No. of experts 2 (two)
 - Senior Expert 1: With 30+ years of relevant expertise. Experience in supervising national-level surveys/ evaluation in any national organisation of the Government of India. Experience of working in any Ministry / Department of the Central Government/ State Government at Additional Secretary equivalent level (Govt of India AS or equivalent pay scale) or above for execution of schemes. Govt of India experience in Health / Education / Nutrition / Agriculture / Infrastructure / Finance / Cooperatives sector at JS level or above shall be an added advantage.
 - Senior Expert 2: With 30+ years of relevant expertise. Experience of working for execution of schemes in any Ministry / Department of the Central Government/ State Government at Joint Secretary equivalent level (Govt of India JS or equivalent pay scale) or above. Govt of India experience in Health / Education / Nutrition / Agriculture / Infrastructure / Finance / Cooperatives sector at JS level or above shall be an added advantage.
- vi. **Pan India Presence**: The Applicant should have a Pan India presence, in at least 5 to 6 States. Each of these offices must be established a minimum of 1 year prior to the EOI advertisement. (Attach copy of rent agreement/ electricity bill/ telephone bill)
- vii. The Applicant should have demonstrated experience in conducting surveys in multiple states and districts. (Copy of work order/Client agreement should be submitted as proof)
- viii. The Applicant must have ISO Certifications, with registration minimum 1 year prior to EoI publication date (copy of certifications should be attached):
 - IS/ISO 9001:2015
 - ISO 31000:2018
 - ISO 26000:2010

4) WORK DURATION

The selected Consulting Firm shall initially be expected to extend services for a period of Three (03) years, and, may be extended by further periods of one (01) year at a time, subject to a maximum of five (05) years. The performance of the Consultancy Firm Partner will be reviewed periodically by SHSSM IITB.

5) WORK BRIEF

IIT Bhubaneswar undertakes high-quality research and is endowed with high calibre teaching professionals. The SHSSM IITB aims to expand its activities to cover various schemes and

projects across the country and, therefore, requires the services of a consultancy firm capable of undertaking large-scale surveys, monitoring of effective implementation and evaluation of various programs/schemes/project (s) across multiple States etc., so as to expand the knowledge base, deepen research and teaching activities of SHSSM.

Such initiatives necessitate deployment of framework strategies including robust design and execution tools for large-scale surveys, monitoring of effective implementation, evaluation of various programs / schemes/ projects across multiple States / UTs and comprehensive assessments of schemes / project components across diverse geographies and across sectors and subjects such as:

- Economic Sector
- Social Sector
- Infrastructure Sector
- Sustainability Sector
- Financial Sector
- Environment Sector
- New and emerging areas

The selected consultancy firm partner will be expected to conduct pre- and post-intervention analyses, field assessments, and data validation exercises, enabling evidence-based policy formulation and implementation plan.

6) SCOPE OF WORK

The selected Consulting Firm along with its third-party partners if needed by the selected Consulting Firm, will provide services and carry out key responsibilities which include, but not limited to:

- Designing and executing large-scale surveys across identified geographies.
- Develop sampling frameworks and survey tools to capture.
- Ensure rigorous field team training, ethical compliance, and quality assurance protocols.

- Establish comprehensive monitoring frameworks to track the implementation of Programs/ Schemes / Project components.
- Monitor critical indicators.
- Assess the coverage and consumption.
- Track improvements.
- Conduct pre- and post-intervention impact assessments and recommend improvements.

iii. Data Management and Analytics

- Collect, validate, and analyse multi-source data to evaluate program/scheme performance and impact.
- Develop dashboards and analytical reports to support real-time decision-making.

- o Generate evidence-based reports, policy briefs, and recommendations.
- Generate actionable insights to inform departmental strategies and future interventions.
