Instructions: The students are advised to read the following information carefully before proceeding for fee payment in the EIMS:

- The students are advised to see their fee amount mentioned in the notice carefully before making the payment, to avoid any excess/ short payment.
- 2) Students have to send the loan sanction letter issued by the bank authority to <u>fa.students@iitbbs.ac.in</u> and a copy to <u>office.academic@iitbbs.ac.in</u> at the time of payment of semester fees.
- 3) The students availing bank loan are advised to generate challan in the EIMS and submit the same to the bank providing the loan.
- 4) The Bank must include the following details of students in the transaction narration field only, without which, the payment will not be accepted.
 - (a) Name of the student
 - (b) Roll No
 - (c) Semester for which the loan has been sanctioned
- 5) If the payment is not updated in EIMS in 5 working days, then the students must communicate the same to EIMS Team.
- 6) Students seeking fee payment extension due to delay in bank loan have to intimate in EIMS on or before 27th December, 2025.
- 7) Students are advised to increase the limit of their bank payment and ensure that the registration fee is paid in a single transaction for a smooth and hassle-free payment.
- 8) Students are advised to pay the full amount of registration fee in one transaction.
- 9) Fee payment, due clearance, and subject registration for all students (including those availing bank loans) must be completed by 5th January, 2025. Thereafter, any delay without a justified reason will be considered as 'Late Registration', and a late fine shall be imposed
- 10) The fee remission amount of all the students who have availed, have been adjusted for the registration fee. The student are requested to pay the balance amount as per the notice.

- 11) Students who have availed Vidyalakshmi and Rabisons scholarships are required to pay the full registration fee as per the notice. The scholarship amount will be reimbursed by the concerned office in the due time.
- 12) Students are advised to make the payment on or before 29th December 2025 in order to begin subject registration from 1st January 2026. The EIMS system requires 2–3 working days to update payments. Therefore, payments made after 29th November 2025 will be reflected after three working days, which may result in a delay in subject registration.
