1. Evaluation of Programme proposals, including title, objectives, subject coverage, syllabus structure, credit framework, and grading methodology.
2. Scrutiny and recommendation for the appointment of Adjunct Faculty/Visiting Faculty, including assessment of qualifications, roles and responsibilities.
3. Recommendation of honorarium/ remuneration/ fee payable to Faculty and resource persons including technical and administrative staffs out of the revenue generated after deduction of the Institute Overhead.
4. Examination and Recommendation of proposals related to the introduction of new outreach initiatives, including E-Master's programmes, Certificate Programmes, collaboration with other Institutions and other continuing education offerings.
5. Ensuring Academic quality, regulatory compliance, and alignment with the Institute's outreach and capacity-building objectives.

The constitutions of the committee will streamline decision-making, ensure uniform academic standards, and facilitate timely launch and monitoring of outreach and E-Master's Programmes as per proposal receipt by the Institute.
