Dear Sir / Madam,

With reference to the subject cited above and the documents under reference, the undersigned is directed to inform you that the Purchase Order issued to your firm for the procurement of **Axial Gas Flow Turbine Cut Section** with a cost of **Rs. 1,49,270/- (Rupees One Lakh Forty-Nine Thousand Two Hundred and Seventy only)** is hereby **cancelled with immediate effect**.

The cancellation has been necessitated on account of the following serious lapses on the part of your firm:


1. Failure to supply the ordered material within the stipulated delivery period, in violation of the terms and conditions of the Purchase Order.
2. Failure to respond or provide any satisfactory clarification regarding the delivery status of the material despite repeated reminders from the Institute.

The above acts constitute a clear breach of contractual obligations. Due to your firm's non-compliance, the teaching and research activities of the Institute have been adversely affected, resulting in an unavoidable disruption of academic and research work.

In view of the foregoing and as per the decision of the competent authority, **M/s. Avijit Aerospace, Bangalore** is hereby **blacklisted** from participating in any tenders and from the supply of any kind of stores/materials to the Institute for a period of **two (02) years**, effective from the date of issue of this letter.
