Dear Sir,

With reference to the subject cited above and the documents referred to, the undersigned is directed to inform you that the GeM Contract issued to your firm for the procurement of **Arduino Digital Signal Processing Board**, amounting to **Rs. 44,940/- (Rupees Forty-Four Thousand Nine Hundred and Forty only)**, stands **cancelled on the GeM portal**, and a consequential **incident** has also been raised against your firm on the GeM portal.

The above cancellation has been necessitated due to the following serious lapses on the part of your firm:


1. Failure to supply the ordered material within the stipulated delivery period, in violation of the terms and conditions of the Purchase Order, citing reasons of price escalation.
2. Failure to respond in a timely manner to official communications, with a response received only after repeated telephonic reminders and emails, and that too with an inordinate delay of approximately **24 days** from the date of release of the GeM order.

The above actions constitute a clear breach of contractual obligations. Due to your firm's non-compliance, the teaching and research activities of the Institute have been adversely affected, resulting in significant disruption to academic and research work.

In view of the foregoing and in accordance with the decision of the competent authority, **M/s Olatus Systems Private Limited, Assam** is hereby **blacklisted** from participating in any tenders and from supplying any kind of stores/materials to the Institute for a period of **two (02) years**, with effect from the date of issue of this letter.

This order is issued in the larger interest of the Institute and with the approval of the competent authority.
