The auction process to select the potential bidder (persons/ registered firm/ contractor) for collecting Cashew nuts from the plantations field at **IIT Bhubaneswar main campus and BoBCO Centre at Laudigaon, Konsi Tahasil, Berhampur 761008 (40 Acres of Land), Adjacent to the IISER Berhampur boundary**, will be conducted as per the information furnished below.

- 1. The date of the auction: 03.03.2026 (Tuesday) at 11.00 AM.**
- Bidders must come prepared with copies of the **Aadhar Card, GST registration certificate***, and **PAN card** issued by Statutory Authorities.
- 3. Venue for the auction:** Meeting Room (Engineering Section), 3rd floor, Administrative Building, IIT Bhubaneswar, Argul, Jatni-752050.
- For participation in auction, the Bidder needs to submit an Earnest Money Deposit (EMD) on the date of auction for each bid amounting as per the details as under in the form of a Demand Draft (DD)/RTGS/NEFT as per Para 10 in favour of Registrar, IIT Bhubaneswar failing which the bidder will not be allowed to participate in the auction process.

7. The bidders are requested to pay a visit to the Bobco campus Laudigaon between 7.00 am to 5.30 pm on any of the working day to assess the exact quantum of the Cashew Nuts before quoting. They will only be allowed to have an inspection in batches by the Institute with proper identity proof at the main gate of the Institute and according to SoP of the Institute (SoP for entry of persons is available on Institute Website). Prospective Bidders may Contact Security Officer for getting the permission to enter the main gate of the Institute.
8. **The minimum reserve price for the sale of cashew nuts is fixed as under:**
(i) **IIT Bhubaneswar, Argul Campus: ₹3,00,000/- (Rupees Three Lakhs only)**
(ii) **BoBCO Campus, Laudigaon, Berhampur: ₹4,00,000/- (Rupees Four Lakhs only)**

Interested bidders shall quote their offered price in a sealed envelope and deposit the same in the designated box before the commencement of the auction process.

9. The bidder who Quotes the highest price (not lower than the reserve price) will be offered the order for the collection of the Cashew nuts. The Bidder who will be considered for the order has to deposit the entire sum of their quoted or negotiated price in the form of DD or NEFT/RTGS Transfer to the Institute. Only after the receipt of the above amount, the Lol/Work Order shall be issued to the highest bidder, failing which the Committee is at liberty to consider the next highest Bidder for the award and ... so on.
